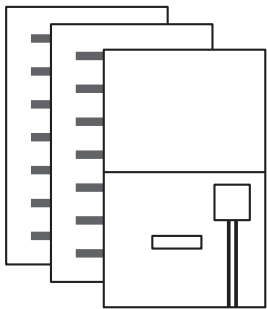

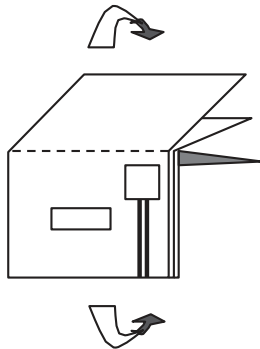

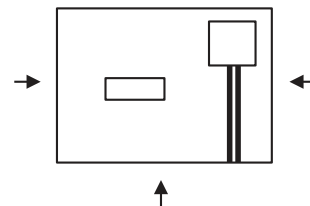
How to use the Business Reply Envelope (BRE)
